Reason for Issuance of this addendum: Revisions by Addendum 02 Further Information of Scope, Increase Contract Time from 60 to 120 calendar Days, provide corrected Structure 4 Map.

1. Minimum Specifications page 24 of 51, General Notes and Specifications, No. 2 Scope Originally Specified:

Contractor to furnish all materials and effort to furnish rock, transport via barge, and place rock.

Revised by Addendum 02: Further Information

Contractor to furnish all materials and effort to furnish rock, transport via barge, and place rock.

If required, the Contractor will remove the channel bottom into the structure location to an elevation of - 3.5 ft. for access.

The excavated material can be placed behind the proposed breakwater in that area.

The excavated material shall be placed to a maximum elevation 1.0 ft. and shall be uniform.

This excavation work will not be paid for directly and shall be considered subsidiary to the placement of the breakwater.

2. Contract Time

Originally Specified:

No mention of a Contract Time was included in the original specifications.

Revised by Addendum 02:

Contract Time

- a. The contract term will be 120 Calendar days from the date of the Notice to proceed.
 - The successful bidder may not commence work under this Contract until authorized to do so by written Notice to Proceed or Purchase Order.
- b. The "Contract Time" is the period of time, including adjustments authorized in accordance with the Contract Documents, allotted in the Contract Documents for Final Completion of the Work. The term "day" as used in the Contract Documents shall mean calendar day unless otherwise specified.
- c. The Work to be performed under this Contract shall be commenced within ten (10) days following receipt of written notice to proceed from OWNER. CONTRACTOR shall perform the Work in a prompt, timely, continuous, and diligent manner.
