A resolution authorizing the execution of an "Application and Agreement for Pipeline/Utility Permit (2020-PL-05)" submitted by ExxonMobil Oil Corporation, requesting permission to install pipes across Ditch Nos. 611, 611-A, 611-A2, 611-C, 1206, 1206-A, 104, 104-B, 100, 200, 200-A, 201, 207, 207-A, 212, 203, 204, 607-E, and 607 (Beaumont/China area), consisting of a combination of 12-in, 10-in and 8-in EMOC pipes and 12-in and 8-in MOP pipes transmitting Ethylene, Propane, and RGP; and also approving permit fees associated with this application totaling \$62,500 (35 crossings @\$1,000, 7 temporary bridges @\$2,500, 1 open cut @5,000, and 1 permanent road access @\$5,000).

- 30. In connection with ExxonMobil Oil Corporation's pipe installations outlined in Pipeline/Utility Permit 2020-PL—005, a resolution authorizing the execution and acceptance of a "Pipeline Easement" to ExxonMobil Oil Corporation labeled as EM-Beaumont 2 Project, over a tract of land owned by Drainage District No 6 on Ditch 200, located in the Shelby Corzine Survey, Abstract No. 14 (southeast of Hwy-124 and south of Tyrrell Park); and also authorizing fees for this easement transaction as follows: \$123,390 for 82.26 rods at \$1,500 each and \$6,420 for Temporary Access Road (\$10.00 per foot for 642 feet).

The execution of an "Application and Agreement for Pipeline/Utility Permit (2021-PL-02)" submitted by Colonial Pipeline Company, requesting permission to perform maintenance (sleeve conversion) on a 40-in gasoline line on Ditch No. 302 was authorized and a fee of \$500 associated with this permit was approved on a motion made by Mr. Daleo, seconded by Mr. Malley, with the voting as follows: ayes—all; nays—none.
