- D. Invocation was given by Mr. Nelson.
- E. Workshop Session
 - There were no easements, street abandonments, and plat reviews to discuss.
 - 2. No comments or reports on various drainage plans and projects.
- F. Public Comments (3 minutes each) - An opportunity for the public to address the Jefferson County Drainage District No. 6 Board of Directors on agenda items or concerns not on the agenda.

 - 2. The receipt and filing of Jefferson County Drainage District No. 6's Investment Schedule for April 30, 2021, pursuant to Section 2256.023 of the Public Funds Investment Act was acknowledged on a motion made by Mr. Daleo, seconded by Mr. Kiker, with the voting as follows: ayes—all; nays-none.

The extension of Jefferson County Drainage District No. 6's existing Depository Contract with Wells Fargo Bank for the period from May 11, 2021 to June 25, 2021, with no changes to the current contract was approved on a motion made by Mr. Daleo, seconded by Mr. Kiker, with the voting as follows: ayes—all; nays—none.
- 4. Notification to Jefferson Central Appraisal District of Jefferson County Drainage District No. 6's intent to participate in the Appraisal District's Board of Directors' elections for the 2022–2023 term of office, pursuant to Section 6.03(c) of the Property Tax Code, was authorized on a motion made by Mr. Daleo, seconded by Mr. Kiker, with the voting as follows: ayes—all; nays—none.
- 5. The receipt and acceptance of Chambers County Appraisal District's 2021 Preliminary Values as of April 22, 2021, pursuant to Texas Property Tax Code, Section 26.09 was acknowledged on a motion made by Mr. Kiker, seconded by Mr. Daleo, with the voting as follows: ayes—all; nays—none.
- 6. Execution of an "Interlocal Agreement" between the City of Beaumont and Drainage District No. 6 regarding the Elinor Street Relief Grant Project, for the purpose of utility adjustments related to the District's installation of culverts under 8th Street near Washington Boulevard, with reimbursement of costs to the City of Beaumont in an amount not to exceed \$70,000.00, was authorized on a motion made by Mr. Daleo, seconded by Mr. Kiker, with the voting as follows: ayes—all; nays—none.

Specifications for Construction of Prefabricated Fleet and Maintenance Building for Jefferson County Drainage District No. 6 (IFB 21-014) were approved, and the advertising for bids and an administrative bid opening for same was authorized on a motion made by Mr. Daleo, seconded by Mr. Kiker, with the voting as follows: ayes—all; nays—none.
