In connection with drainage improvements on Ditch No. 207-A (Hwy-90/west Beaumont), consider a resolution accepting a "Drainage Easement" donated by Entergy Texas, Inc. consisting of the actual width of the aforementioned ditch, including improvements, plus 25 feet of the ditch tops that lie on its property located in the James Gerish Survey, Abstract 24, in Jefferson County, Texas.
 - 2. In connection with drainage improvements on Ditch 800 (Hwy-90/Nome), consider a resolution accepting a "Drainage Easement" donated by Entergy Texas, Inc. consisting of the actual width of the aforementioned ditch, including improvements, plus 25 feet of the ditch tops that lie on its property located in the Susanah Horton Survey, Abstract 30, Jefferson County, Texas.
 - 3. In connection with drainage improvements on Ditch No. 613-B1 (East Vera and N. Beaumont Streets) consider a resolution accepting a "Drainage Easement" donated by Stanolind O&G Dishman, LLC, consisting of the actual width of the aforementioned ditch, including improvements, plus 25 feet of the ditch tops that lie on its property located in the Sophia Deen Survey, Abstract 16, in Jefferson County, Texas.
