I. Board and/or Staff comments:

Mr. Malley commented on the first hearing for the Flood Infrastructure Fund Regional Watershed Study noting that it was well put together and very successful, "Great job." Mr. Allen inquired if any comments were received at the hearing that would lead to new focus areas for flood relief or changes needing to be made. Mr. Canant replied yes, with one in the north end of Beaumont, and that the District's staff is already working on it.

Mr. Malley initiated a brief discussion about a matter he was made aware of concerning changing the employee work schedule. Mr. Canant advised the Board that there has been a lot of interest from field personnel and that the staff is currently researching/discussing the possibility of changing the work schedule from five 8-hr. days to four 10-hr. days. Mr. Canant explained that should the matter seem feasible, the Board would be provided with information regarding the proposed work schedule change, with the possibility of having an item on a future agenda for their consideration.

Mr. Malley brought up the subject of exempt employees versus non-exempt employees. Mr. Canant turned the floor over to Mr. Mann, who led a discussion regarding the differences between the two, and the District's current policy and expectations regarding the matter.

Mr. Canant commended Mrs. Ferguson and her staff for all the work and effort spent in tracking time/expenses and providing the information required by the grant agency that resulted in the District receiving a check for \$1,000,000+ related to the FIF Regional Watershed Study grant.

Mr. Allen thanked the Board members and staff who participated in the employee insurance discussions/meetings, which was a very complicated and challenging matter. Mr. Malley noted that Ms. Ferguson did a great job in providing all the numbers and information needed for the committee to make an informed decision for the upcoming coverage year. Mr. Daleo concurred, and then there was a brief discussion about some of the committee's discussion points and findings.

J. There were no further comments and Mr. Allen called for adjournment of the meeting.
