That this "Amended Information Form" is being filed by Jefferson County Drainage District No. 6, with the County Clerks of Jefferson County, Texas and Chambers County, Texas, pursuant to Section 49.455 of the Texas Water Code, as amended; accordingly, the following information is provided:

- 1. The name of the district is Jefferson County Drainage District No. 6.
- 2. A complete and accurate legal description of the boundaries of the District is attached hereto as Exhibit "A."

A complete and accurate map showing the boundaries of the District is on file in the offices of the County Clerk of Jefferson County, Texas, recorded in File # 2015024695, Jefferson County Official Public Records.

- 3. The most recent rate of District taxes on property located in the District is \$0.192429 per \$100 valuation.
- 4. The total amount of bonds, excluding refunding bonds and any bonds or any portion of bonds issued that are payable solely from revenues received or expected to be received under a contract with a governmental entity, approved by the voters and which have been or may, at this date, be issued is \$0.
- 5. The aggregate initial principal amounts of all bonds issued for one or more of the specified facilities of the district and payable in whole or in part from property taxes is \$0.
- 6. A standby fee is not imposed by the Drainage District.
- 7. The date on which the election to confirm the creation of the District was held was January 10, 1920.

By special act of the Legislature (H. B. 1063, Acts of 57th Legislature, R. S.), the Drainage District was converted to a conservation and reclamation district; and its boundaries were enlarged as shown on Exhibit "A" attached hereto.

8. The functions performed by the District include, but are not limited to, protection against flooding and overflow from rain waters, tide waters, and other waters, and the right and authority to construct, erect, improve, operate, and maintain canals, ditches, laterals, levees, and other structures necessary to carry out those protections.

9. The particular form of "Notice to Purchasers" required by V. T. C. A., Water Code, Section 49.452, to be furnished by a seller to a purchaser of real property in the District is attached hereto as Exhibit "B" and made a part hereof for all purposes.



EXHIBIT "A"

TRACT ONE

BEGINNING at the common line between Jefferson and Liberty Counties at its intersection with the right descending bank of Pine Island Bayou;

THENCE down the right descending bank of Pine Island Bayou with its meanders to its intersection with the right descending bank of the Neches River;

THENCE down the right descending bank of the Neches River with its meanders to a point where the northerly projection of a line parallel with and 2,000 feet easterly of the centerline of Carroll Street would intersect said right descending bank of the Neches River;

THENCE in a straight line in a southeasterly direction to the northeast corner of the James W. Bullock Survey, said point also being the northwest corner of the B.S.& F. Section No. 11;

THENCE in a southerly and southeasterly direction along the easterly boundary line of said James W. Bullock Survey, the westerly boundary line of said B.S.& F. Section No. 11, and the westerly and southerly boundary lines of the Jeff and Jas Chaison Survey to a point in the southerly boundary line of said Chaison Survey where the northwest boundary line of the Pelham Humphries Survey intersects the same;

THENCE southwesterly, southeasterly, and southwesterly along the northwest boundary line of said Pelham Humphries Survey to its intersection with the west line of the Union Pacific Railroad Company (formerly known as the Sabine and East Texas Railway Company) right-of-way;

THENCE southeasterly along the west line of said right-of-way to its intersection with the top of the northerly bank of the McFaddin, Wiess, Kyle Land Company's No. 2 Canal;

THENCE in a southwesterly direction along the top of the northerly bank of said No. 2 Canal with its meanders to its intersection with the centerline of Hillebrandt Road in the Marcelan Grange League;

THENCE south along the centerline of said Hillebrandt Road to the center of Hillebrandt Bayou;

THENCE down the center of Hillebrandt Bayou with its meanders to its intersection with the center of Taylor's Bayou;

THENCE up the center of Taylor's Bayou with its meanders passing the **POINT OF COMMENCING** of Tract Two, and continuing along the centerline of Taylor's Bayou, passing the most northerly northwest corner of Tract Two at the common line between Labelle Ranch and M Half Circle Ranch, and continuing along the center of Taylor's Bayou with its meanders to the point where the center of the North Fork of Taylor's Bayou and the center of the South Fork of Taylor's Bayou meet;

THENCE up the center of the South Fork of Taylor's Bayou with its meanders, to its intersection with the east line of the B.B.B. & C.RR. Co. Survey;

THENCE north along the east line of said B.B.B. & C.RR. Co. Survey to its northeast corner, which is also the southeast corner of the David Burrell Survey;

THENCE west along the south line of said David Burrell Survey to its southwest corner in the east line of the William H. Smith League;

THENCE in a straight line in a northwesterly direction across said William H. Smith League to the southeast corner of the J. P. Probarth Survey in the north line of said Smith League;

THENCE west along the north line of said William H. Smith League to its northwest corner, which is also the northeast corner of the W. D. Cotton Survey;

THENCE south along the east line of said Cotton Survey to its southeast corner;

THENCE west along the south line of said Cotton Survey to its southwest corner in the east line of the Christopher Teal Survey;

THENCE south along the east line of said Teal Survey to its southeast corner;

THENCE west along the south line of said Teal Survey to its southwest corner;

THENCE north along the west line of said Teal Survey to the south line of Texas and New Orleans Railroad Section No. 86, said point being also the northeast corner of the Texas and New Orleans Railroad Survey No. 267;

THENCE west along the south line of the Texas and New Orleans Railroad Sections No.'s 86, 85, and 84 to the southwest corner of said Section 84 in the common line between Jefferson and Chambers Counties;

THENCE north along the common line between Jefferson and Chambers Counties to the northeast corner of Chambers County, the same being an inner corner of Jefferson County;

THENCE west along the common line between Jefferson and Chambers Counties to the point where said common county line intersects the west line of the Texas and New Orleans Railroad Section No. 80;

THENCE north along the west line of said Section No. 80 to its northwest corner;

THENCE continuing on the same course north across the Texas and New Orleans Railroad Sections No.'s 70 and 67 to the north line of said Section No. 67;

THENCE west along the north lines of Texas and New Orleans Railroad Section No. 67, A-214 to the west right-of-way of the Lower Neches Valley Authority Neches South Canal;

THENCE southwesterly along the west right-of-way line of the said Neches South Canal, across the said A-214 to the northwest right-of-way line of the Lower Neches Valley Authority Winnie Canal;

THENCE southwesterly along the northwest right-of-way line of the said Winnie Canal, across the said A-124 to its west line, and the east line of the H.S. Spangler Survey, A-722, and continuing southwesterly along the northwest line of the said Winnie Canal, across the southeast portion of the said A-722 to its south line;

THENCE west along the south line of the said A-722 to its southwest corner;

THENCE north along the west line of the said A-722 to its northwest corner and the southeast corner of the G.K. Petry Survey, A-882;

THENCE west along the south line of the said A-822 to the common line between Jefferson and Liberty Counties;

THENCE north along the common line between Jefferson and Liberty Counties to the **PLACE OF BEGINNING**.

TRACT TWO

BEGINNING at the intersection of the centerline of Taylor's Bayou, with the northerly extension of the east line of the Bennett Blackman Survey, A-2; **THENCE** south, down the northerly extension of the east line of the said A-2, and the east line of the said A-2, to the north right-of-way line of State Highway No. 73;

THENCE northeasterly down the north right-of-way line of State Highway No. 73, across the Archibald Hotchkiss Survey to the southwest corner of a Labelle Property tract being Tract 16, A-31 in the Jefferson County Appraisal District Records, and being recorded in Film Code 105-16-0794 of the Real Property Records of Jefferson County;

THENCE north up the west line of the said Labelle tract to its northwest corner, and continuing north up the west line of a B.C. Hebert Heirs tract recorded in Volume 31, Page 88 of the Deed Records of Jefferson County, to the south right-of-way line of the east/west portion of Country Club Road;

THENCE east along the south right-of-way line of Country Club Road, passing the west right-of-way line of the north/south portion of Country Club Road, and continuing east across its right-of-way to its east right-of-way line.

THENCE north down the east right-of-way line of Country Club Road to the south line of Lake Estates as recorded in the Map Records, Vol. 17, Page 342, and a north line of the aforementioned B.C. Hebert Heirs tract;

THENCE east, north and east along the north line of the B.C. Hebert Heirs tract, and the south line of Lake Estates to a southwesterly line of the B.F. Calhoun Survey, A-818;

THENCE continuing east along the north line of the said B.C. Hebert Heirs tract, and the south line of Lake Estates, across the said A-818, to its east line, and the west line of the H.A.F. Survey, A-839;

THENCE south along the A-839 west line and the A-818 east line, to the northwest corner of the Carl Bengel Survey, A-402;

THENCE east along the north line of the A-402 to its northeast corner;

THENCE south along the east line of the said A-402, passing the southeast corner of the said A-402 and the northeast corner of Emile Broussard Survey, A-447, and continuing south along the east line of the said A-447 to the northwest corner of the T.&N.O.RR. Co., Section 267, A-322;

THENCE east along the north line of the said A-322 to its northeast corner;

THENCE south along the east line of the said A-322, passing its southeast corner and the northeast corner of the Anthony Oswald Survey, A-768, and continuing south along its east line to the northwest corner of the T.&N.O.RR. Co., Section 299, A-328;

THENCE east along the north line of the said A-328, passing its northeast corner and the northwest corner of the Nathan Blevins Survey, A-740, and continuing east along its north line passing its northeast corner and the northwest corner of the T.&N.O.RR. Co., Section 301, A-329, and continuing east along its north line to its northeast corner;

THENCE south along the east line of the said A-329, to its southeast corner, and the northeast corner of the T&N.O.RR. Co., Section 309, A-298, and continuing south along its east line to its southeast corner and the northeast corner of the T.&N.O.RR. Co., Section 315, A-300, and continuing south along its east line to its southeast corner;

THENCE west along the south line of the said A-300 to its southwest corner, and the southeast corner of the Anthony Oswald Survey, A-766, and continuing west along its south line to its southwest corner in the east line of the T.&N.O.RR. Co., Section 313, A-299;

THENCE south along the east line of the said A-299 to a point for a southeast corner of Labelle Ranch, and an interior corner point in the north line of the U.S. Fish and Wildlife Services McFaddin National Wildlife Refuge;

THENCE west across the said A-299, along a said Labelle Ranch south line to a southwest corner of the said A-299, and the southeast corner of the T.&N.O.RR. Co., Section 209, A-274, and continuing west along its south line to its southwest corner, and the southeast corner of the L.J. Hebert Survey, A-500, and continuing west along its south line to its southwest along its south line to its southwest corner, and the southeast corner of the T.&N.O.RR. THENCE east along the north line of the said A-340 to its northeast corner, and the northwest corner of the Seth Davis Survey, A-490, and continuing east along its north line to its northeast corner, in the west line of the Joseph E. Broussard Survey, A-485;

THENCE north along the west line of the said A-485 to its northwest corner, and the southwest corner of the T.&N.O.RR. Co., Section 199, A-269, and continuing north along its west line to the northwest corner of its south half;

THENCE east along the north line of the south half of the said A-269 to its east line, and the west line of the William B. Burton Survey, A-8;

THENCE south along the east line of the said A-269 and the west line of the said A-8 to the southeast corner of the said A-269;

THENCE east along the common line between M Half Circle Ranch and Labelle Ranch across the said A-8 to a southeast corner of the M Half Circle Ranch, and an interior corner of the Labelle Ranch;

THENCE north, east, north, east, and then north, across the said A-8, along the common line between M Half Circle Ranch on the west, and Labelle Ranch on the east, to the most northerly northwest corner of the herein described tract in the centerline of Taylor's Bayou;

THENCE along the centerline of Taylor's Bayou with its meanders in all overall northeasterly direction to the **PLACE OF BEGINNING**;
