H. Business Session:

1. Consider a resolution authorizing the payment of routine bills received for the month of June 2025, that were not expressly authorized or denied for payment elsewhere on this agenda.
2. Acknowledge the receipt and filing of Jefferson County Drainage District No. 6’s “Investment Schedule for May 2025.”
3. Consider a resolution authorizing the execution of an “Engagement Letter” received from FMW, PC, for the preparation of the District’s basic financial statements for the fiscal year ending September 30, 2025.

4. Consider a resolution authorizing the execution of an “Engagement Letter” received from Pollans & Cohen, P.C. for the District’s annual audit for the fiscal year ending September 30, 2025.
5. Consider a resolution authorizing the adoption of Jefferson County Drainage District No. 6’s updated “Drainage Criteria Manual” (July 2025) pursuant to Section 49.211 of the Texas Water Code, and in connection with Jefferson County Drainage District No. 6’s Master Drainage Plan adopted on February 27, 2007.
6. In connection with drainage improvements on Ditch 1204-E (Bevil Oaks), consider a resolution authorizing the acceptance of a “Drainage Easement” donated by the City of Bevil Oaks (“City”) consisting of the actual width of Ditch 1204-E where it is located on the City’s property, and 15 feet on each side of the ditch tops that lie on the City’s property located in the William C. Dyches Survey, Abstract 112, Bevil Oaks, Jefferson County, Texas.
7. In connection with drainage improvements on Ditch 713 (Hamshire), consider a resolution authorizing the acceptance of a “Drainage Easement” donated by John C. Deaton, Jr. consisting of the actual width of Ditch 713 where it is located on his property, and 25 feet on each side of the ditch tops that lie on his property located in the John Fannett Survey, Abstract 461, Jefferson County, Texas.
8. In connection with requests for qualifications received on June 24, 2025, for “Professional Services – Property Appraisals” (RFQ 25-014 KKJ), and pursuant to the Evaluation Committee’s recommendation, consider a resolution accepting the qualifications received from Cook & Associates, Inc. Real Estate Appraisers, with awards to be made on a per property basis, as needed.
9. In connection with the term contract for Motor Fuel for Jefferson County Drainage District No. 6 (IFB 21-015/KJS) awarded on August 10, 2021, consider a resolution authorizing the execution of the final of four 1-year renewal options with Tri-Con, Inc. and Sun Coast Resources, Inc., extending their contract expiration dates from August 7, 2025, to August 6, 2026, and no other contract changes.
10. In connection with the term contract for Herbicides for Jefferson County Drainage District No. 6 (IFB 24-011/SC) awarded on July 16, 2024, consider a resolution authorizing the first of four 1-year renewal options with Red River Specialties, LLC and Helena Agri-Enterprises, LLC, extending their contract expiration dates from July 2, 2025, to July 1, 2026, and no other contract changes.
11. In connection with the term contract for Catalogue Pricing for Grass, Cover Seed, and Fertilizer for Jefferson County Drainage District No. 6 (IFB-24-023/SC) awarded on July 25, 2024, consider a resolution authorizing the first of four 1-year renewal options with M&J Fertilizer Co., extending their contract expiration date from July 24, 2025, to July 23, 2026, and no other contract changes.
12. In connection with the term contract for Erosion Control Mats for Jefferson County Drainage District No. 6 (IFB-24-015/KJS) awarded on July 16, 2024, consider a resolution authorizing the first of four 1-year renewal options with Premier Concrete Products, Inc., extending their contract expiration date from July 15, 2025, to July 14, 2026, and no other contract changes.


