Job Summary:

Plans, coordinates and directs the tasks, goals and objectives of the Engineering Department. Supervises personnel engaged in the practice of civil engineering work related to the design, construction and maintenance of drainage infrastructure.

Duties/Responsibilities:

- Directing, assisting, training and continuing education in the areas of engineering design, construction inspection, surveying and activities related to the maintenance and operation of public drainage systems
- Communicating and collaborating with other department managers and representatives of state and local governmental entities, engineering firms, contractors, private parties and the public
- An employee at this level is virtually self-supervised and assumes direct accountability for the product

Other Job Functions:

Performs other duties as required. Job description statements are intended to describe the general nature and level of work being performed by employees assigned to this job title. They are not intended to be construed as an exhaustive list of all responsibilities, duties and skills required.

Required Knowledge:

- Considerable knowledge of the methods and techniques applied to the inspection, evaluation, design, construction, and maintenance of drainage infrastructure
- Considerable knowledge interpreting geotechnical reports for the design of embankments and structures
- General knowledge of hydrology and hydraulic design for rural and urban areas
- General knowledge of hydrology and hydraulic design programs including, but not limited to, HEC-RAS and HEC-HMS
- General knowledge of federal, state, and local laws, regulations and guidelines related to civil construction and public drainage systems

Required Skill / Abilities:

- Skilled in the review, interpretation, and preparation of technical reports, construction plans, detail drawings, and specifications
- Ability to communicate effectively both verbally and in written form
- Ability to manage multiple projects in various stages of development simultaneously

Required Education and Experience:

Education:

- Bachelor's degree in civil engineering from an accredited college or university
- Minimum of five (5) years of progressively responsible engineering-related experience

Experience:

- Minimum of one (1) year supervisory/managerial experience. Project leader or lead worker experience may substitute for supervisory/managerial experience.

Required certificates, licenses, or accomplishments:

- Valid Driver's license
- Professional Engineer (PE) licensed by the Texas Board of Professional Engineers
- Registered Professional Land Surveyor (RPLS) preferred, but not required

Working Conditions:

The normal work schedule for this position is Monday – Thursday from 7:00am to 5:30pm. This position will require work to be performed in an office environment and occasionally within civil construction sites. Work performed in the field may result in exposure to various climatic conditions and potentially high noise levels. Personal protective equipment (PPE) may be required to be worn as determined by the specific work location and type of work being performed.

Physical Requirements:

- Type, handwrite, walk, sit, stand, climb, kneel, squat, stoop, twists body, and operate a vehicle
- Lift, hold and carry objects weighing up to 10 lbs.
- Push and pull objects weighing up to 25 lbs.
